Projects shared how they are returning back to in person programming.

Some are continuing to offer virtual programming in a hybrid model. Many program sites are slowly returning to pre-pandemic numbers. Virtual lens enabled some projects to offer a variety of online activities and expert panels. Some partner programming continue to run virtually. Some programs offer virtual online home visiting if family/ participant unable to attend in person.

Retaining and filling staff positions continues to be a challenge; especially when comparing positions and available salaries. Some projects have had success in having clients transition from being participants into staffing. Difficulty to match salaries to hold on to programming staff.

Many projects have not had public health nursing returning to program support as in pre pandemic levels. Some projects are continuing with food delivery and some looking at fresh produce delivery in partnership with Food Share during Thanksgiving and first week in November.

Successful stories sharing when program participants have returning as HRSDC summer staffing.

Some projects shared activities and focus of shared knowledge around what activities they will be doing for September 30th. Some projects get the day off and have preplanned virtual programming taking place.

Discussed renewal and actual decrease in funding since we are not addressing Cost of Living increases an impacts on budget. We are able to move 15% of budget lines without preapproval. Suggest that projects discuss budget impacts with PC during upcoming monitoring calls. Renewal up to 2025 without increases will impact program delivery. Many projects have not had any increases over 20 years. Will need to look at readjusting work plans and what projects can address. Yvette suggested the possibility of sharing works plans in Google docs with other programs. Sharing of ideas and focuses across the Zone and projects.

Discussion around inflection impact on salaries and unions within associated projects. The estimated Social Security cost of living adjustment (COLA) for 2023 is **8.7%**, according to The Senior Citizens League, a non-partisan seniors advocacy group. Its estimate was updated on Sept.
